Pre-K Before & After School Program Fees

Niagara Falls Boys & Girls Club • Niagara Falls School 79th St Elementary

The Niagara Falls Boys & Girls Club Blue Door Academy at 79th Street Elementary is partially funded through program fees. We use program fees to cover robust, fun, enriching curriculum provided by paid professional staff based on a Positive Youth Development Model, serving children in Pre-K through Grade 6. There are several enrollment options for parents/guardians. No child will ever be turned away based on inability to pay.

We offer access to the NYS Child Care Subsidy, financial assistance, and a significant advance-pay discount — pay the month in advance and save 50%!

Type	Fee	Description
Pre- K After School Program	\$27/day \$135/week \$540/month	Monday–Friday, school dismissal to 6:00 pm, every regularly scheduled school day. 50% discount for paying the month in advance (\$270/month). Additional 20% sibling discount for each additional enrolled child (\$216/month per sibling).
Pre-K Before School Program	\$12/day \$60/week \$240/month	Monday–Friday, 7:00 am to the start of the school day. 50% discount for paying the month in advance (\$120/month). Additional 20% sibling discount for each additional enrolled child (\$96/month per sibling).
Pre-K Before & After School Program	\$39/day \$195/week \$780/month	Both sessions, Monday–Friday. 50% discount for paying the month in advance (\$390/month). Additional 20% sibling discount for each additional enrolled child (\$312/month per sibling).
Registration Fee	\$25/child \$50 family max	Due at registration for the school year. \$25 per child, capped at \$50 per family no matter how many children you enroll. Covers registration processing and program materials.

*** Advance pay = payment must be received prior to the 1st of the month of service.**

**** Sibling discount = first child pays the advance-pay rate; each additional child in the same household receives an extra 20% off the advance-pay rate. Sibling discount applies to advance-pay families only.**

Monthly fees assume a typical 4-week month; see the Payment Policy for proration when school is closed.

Child Care Assistance through Niagara County Department of Social Services

This Niagara Falls Boys & Girls Club program location is a licensed School Age Child Care program eligible to receive child care assistance payments for eligible families. We encourage all families to put their tax dollars to work and explore this option for program payment support.

Income limits are updated by New York State each year and typically increase — check the website below for the current chart before ruling yourself out.

- Do you work a minimum of 10 hours a week, go to school, attend a vocational program, or are you seeking employment?

If you answered yes to both questions, you may qualify for New York State childcare assistance to pay almost all of your program fees — most families pay only a \$1 to \$10 weekly family share, and some pay nothing at all. One family share covers all of your enrolled children.

Payment Policy

- No child will be turned away from the program based on inability to pay.
- All enrollment and financial paperwork, including the one-time enrollment fee, must be reviewed and signed off with acceptance of the payment fee and schedule prior to your child's attendance.
- If there are more than 4 days in a month with no program for any reason (holiday, weather, etc.), that monthly fee will be prorated accordingly. Pre-payment agreements will be given credit for the next month.
- The first month of enrollment and the enrollment fee are non-refundable.
- Families applying for Child Care Assistance pay only their county-set weekly family share once approved. Please provide a copy of your application or approval notice to the program office.

_____ **Sibling Discount (additional 20%)** — for each additional child in the household enrolled with advance pay.
