The Niagara Falls Boys & Girls Club Learning & Enrichment After School Program is partially funded through program fees. We use program fees to cover robust, fun, enriching curriculum provided by paid professional staff based on a Positive Youth Development Model. There are several enrollment options for parents/guardians. No child will ever be turned away based on inability to pay.

Type	Fee	Description
After School Program	\$27/day \$135/week \$540/month	For those you are not enrolled in LEAPS program. Program is still M-F 3pm - 6pm. 50% discount for paying the month in advance (\$270/month). Additional Discount if set up auto pay advance payments (\$203/month pd)
Before School Program	\$12/day \$60/week \$240/month	For those you are not enrolled in LEAPS program. Program is still M-F 7am – 9am. 50% discount for paying the month in advance (\$120/month). Additional Discount if set up auto pay advance payments (\$90/month pd)
Before & After School Program	\$39/day or \$195/week or \$780/month	For those you are not enrolled in LEAPS program. Program is still M-F 3pm - 6pm. 50% discount for paying the month in advance (\$390/month). Additional Discount if set up auto pay advance payments (\$293/month pd)
School Break Program	\$39/day	Full Day programming (7:30 am to 6pm) offered at the 17 th Street Clubhouse on certain school holidays/breaks. Pre-Registration is required and will be posted no less than 2 weeks prior to the no school day. Advance payment gives discount to \$17/day.

***Advance pay = payment must be received prior to the 1st of the month of service.**

**** Advance Auto Pay – Credit card is automatically charged the 1st of the month for services.**



Child Care Assistance through Niagara County Department of Social Services

This Niagara Falls Boys & Girls Club program location is a licensed School Age Child Care Center and eligible to receive childcare assistance payments for eligible families. **The income threshold to qualify for payment support was recently increased.** We encourage all families to put their tax dollars to work and explore this option for program payment support.

- Do you work a minimum of 10 hours a week or go to school or attend vocational program or seeking employment?

If you answered yes to both those question you may qualify for NYS Office of Children Services through the Niagara County Department of Health to pay almost all of your after-school fees – most parents only pay \$1 to \$10 co-pay, some may not pay anything at all.

Payment Policy

No child will be turned away from the program based on inability to pay.

All enrollment and financial paperwork must be reviewed and signed off with acceptance of payment fee and schedule prior to your child's attendance.

If there are more than 4 days in a month with no program for any reason (holiday, weather, etc.) that monthly fee will be prorated accordingly. Pre-Payment agreements will be given a credit for the next month.

1st month of non-LEAPS enrollment is non-refundable.
